## **Proposal from Bert Whitehead**

We establish a program where we meet with the various members of the community that have difficulty receiving KBRP and find out if they would be likely to listen to KBRP and become a member if we provide them with the means to do so. i.e., an Alexa or Google Home (provided they have internet). If there is sufficient interest Mr. Whitehead would be willing to provide a grant to purchase the units.

## **Background**

Bert Whitehead grew up in Bisbee (family owned the furniture store) and while he left to pursue a career as a tax attorney and financial planner in Michigan he has maintained strong ties with his home town of Bisbee and has many friends here. Now retired he divides his time between Michigan and Tucson with regular visits to Bisbee.

He contacted me in January of this year regarding a \$1000 donation he made through his Donor Advised Fund which is a giving account established at a public charity. It allows donors to make a charitable contribution, receive an immediate tax deduction and then recommend grants from the fund over time.

Mr. Whitehead contacted us at the beginning of the month to discuss this briefly. I (Sandy) talked with him extensively over the phone one day. The discussion led to our problem of extending our transmission to the areas of Bisbee outside of Old Bisbee. While the wattage increase has helped some there are areas, especially once you go past the county transfer station that rely solely on streaming. Also, streaming allows us to reach areas that are not covered by our radius limit. I jokingly mentioned that we should provide smart speakers like Alexa Echo or Google Home if someone wants to listen to KBRP and be a member but can't conveniently receive the streaming. His ears perked up, he asked could he receive KBRP in Tucson on his Alexa. I told him yes and immediately went and found it.

He visited the radio station last week along with one of his childhood friends who continues to live in Bisbee in the Warren area. We continued the discussion regarding the providing of smart speakers that access virtual assistants such as Alexa to community members that would use them to listen to KBRP and potentially become members. We also discussed that one can access KBRP through a Smart TV if they have one. But many do not know how to do so. (After our meeting Bert and his grandson went to the home of his friend and set up his Smart TV. Bert informs me that the friend now listens to KBRP daily.
